The scope includes any action, process, activity or project that has a positive effect on the environment and/ or a community. It may be large or small, a one-off, an ongoing formal project or someone's idea that has been put into practice.

## Conditions of entry

This award may be entered by any AQA financial member company or their employee. It must be endorsed by the General Manager or CEO of the company.

Entering indicates agreement for the AQA to manage the publicity of the award, and cooperation from the resulting winner is required. This will include written and photo material about the award recipients.

The winner will be announced at the QuarryNZ 2021 Conference in Wellington on **Friday 16th July 2021**.

## Judging criteria

Sustainability and climate change consultant Bernie Napp will contact finalists to judge:

- The degree of positive environmental and/ or community impact
- A contribution to reduced energy usage and/ or carbon emissions reduction
- Originality and innovation
- The level of difficulty involved
- Other aspects that are considered relevant
